## ASSIGNMENT

WHEREAS, we **Randy Paul Bordelon, Matthew Stephen James Lanigan, Kenneth Edward Durio** and **James Kerwin McDowell** have invented certain new and useful methods, devices, and systems relating to insulating a support mat having an electrically-conductive cover (collectively, the "Inventions") for which a United States regular utility patent application entitled "**APPARATUS AND METHODS FOR INSULATING A SUPPORT MAT HAVING AN ELECTRICALLY-CONDUCTIVE COVER**" was filed under attorney docket number 025020-04301-CIPH on October 11, 2017 and assigned Serial Number 15/730,631 (the "Application"); and

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) and for other good and valuable consideration, the receipt of which is hereby acknowledged, I hereby sell, assign, transfer and set over to **NEWPARK**, all right, title and interest in and to said Inventions throughout the world, and said Application, and any and all other provisional applications and regular U.S. and foreign patent applications relating to the Application or Inventions and any and all divisions, continuations, continuations-in-part and other patent applications relating or claiming priority thereto and reissues thereof, all such applications and the Application being collectively referred to herein as the "Applications", and any and all patents of the United States and foreign countries which may be granted on the Applications, the same to be held and enjoyed by **NEWPARK** for its own use and benefit, and for the use and benefit of its successors, assigns, or other legal representatives, to the end of the term or terms for which said patents of the United States or foreign countries are or may be granted or reissued, as fully and entirely as the same would have been held and enjoyed by me if this assignment and sale had not been made.



applications or other patent applications based upon the Application, secure a reissue of such patent(s) or to file a disclaimer relating thereto, I will upon request, sign all papers, make all rightful oaths and do all lawful acts requisite for the filing and procuring thereof without further compensation but at the expense of said assignee, its successors or other legal representatives.

And I do further covenant and agree that I will, at any time upon request, communicate to **NEWPARK**, its successors, assigns or other legal representatives, such facts relating to said Inventions, Applications and patents and the file histories thereof as may be known to me, and testify as to the same in any interference or other administrative proceeding or litigation when requested so to do, without further compensation but at the expense of said assignee, its successors, or other legal representatives.
