ASSET PURCHASE AGREEMENT

This Asset Purchase Agreement (the "Agreement") is made this 01.05.2018 (the "Effective Date"), by and between **Dušan Marinko** (born 26.5.1958) residing at Kukorellího 55, SK-08501 Bardejov, Slovak republic (the "Proprietor") and
Successor 1 - **Dušan Marinko** (born 26.5.1958) residing at Kukorellího 55, SK-08501 Bardejov, Slovak republic
and Successor 2 - **Dušan Marinko** (born 4.9.1986) residing at Kukorellího 55, SK-08501 Bardejov, Slovak republic (jointly the "Successors").

RECITALS

WHEREAS, the Proprietor is the sole and exclusive owner of, and has the sole and exclusive right to the patent applications based on Slovak utility model application No. PUV50081-2015 and PCT/SK2015/050004 according the following list, with title: "PET WASTE DISPOSAL DEVICE", with priority of 26.8.2015.

IN CONSIDERATION of the matters described above, and of the mutual benefits and obligations set forth in this Agreement, the Parties agree as follows:

GRANT OF PATENT

Proprietor now owns and wishes to sell the listed Patent Applications to the Successors; and Successors wish to purchase the Patent from the Proprietor.

By this Agreement the Proprietor transfers all national patent applications based on PCT/SK2015/050004 in Canada, China, Japan, Russian Federation, Ukraine and USA and European patent application No. 15475501.1 to the Successors.

PRICE

The price is the subject of a separate Agreement.

EXTENT OF OWNERSHIP

The Successors have agreed on the co-ownership according the following percentage:

Successor 1 - Dušan Marinko (born 26.5.1938) will own 35% of the co-owner share.

Successor 2 - Dušan Marinko (born 4.9.1986) will own 65% of the co-owner share.

OTHER TERMS AND CONDITIONS

From the Effective Date of this Agreement, the Successors have the sole and exclusive right to institute and prosecute any and all suits to enjoin any and all infringers of the abovementioned Patent Applications.

This Agreement comes into effect on the day of its signature by both Parties and is concluded for an indefinite time period.

This Agreement relates to all legal successors of both Parties in case of their cessation or transformation.

From the Effective Date of this Agreement, the Successors acquire all rights and are obligated to all obligations that arise from the ownership of the Patent Applications.

The Successors are required to apply for the Assignments of above mentioned national phase of patent application at the local Patent Offices.

AMENDMENTS

This Agreement may not be amended unless such amendment is in writing and is signed by both Parties to this Agreement.

BINDING EFFECT OF THE AGREEMENT

Issues not covered by this Agreement shall be governed by the provisions of the Commercial Code of the Slovak Republic.

This Agreement shall be binding and shall apply to the Proprietor and the Successors, and may inure to the benefit of, may be transferable to, and be binding upon the Proprietor and Successors.


The Agreement has been signed in three (3) duplicate originals.
