RESTATED CERTIFICATE OF INCORPORATION OF
GLAM MEDIA, INC.

Glam Media, Inc., a corporation organized and existing under the General Corporation Law of the State of Delaware (the "Corporation"), DOES HEREBY CERTIFY:

FIRST: The original Certificate of Incorporation of the Corporation was filed with the Secretary of State of Delaware on July 16, 2004 under the name Project Y, Inc. The Restated Certificate of Incorporation of the Corporation was filed with the Secretary of State of Delaware on March 17, 2014 under the name Glam Media, Inc.

SECOND: A Certificate of Amendment to the Restated Certificate of Incorporation of the Corporation was filed with the Secretary of State of Delaware on June 17, 2005 changing the name from Project Y, Inc. to Glam Media, Inc.

THIRD: In accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware, a resolution setting forth this amendment to the Restated Certificate of Incorporation of the Corporation as set forth below has been duly adopted by the board of directors of the Corporation, and has been consented to in writing by the stockholders of the Corporation pursuant to Section 228 of the General Corporation Law of the State of Delaware.

FOURTH: Article First of the Restated Certificate of Incorporation as presently in effect be, and the same hereby is, amended and restated to read in its entirety as follows:

"The name of the Corporation is Mode Media Corporation."
