## PATENT ASSIGNMENT AGREEMENT

THIS AGREEMENT is made this 15 day of March, 2018, by and between Rochelle Woodeshick, June Krolkowski and Pearl Briggs (collectively, "Assignors") and Valerie Strange ("Assignee") (collectively the "Parties").

WHEREAS, the Parties hold all rights title and interest to Patent No. 8,117,675 and Patent Application Ser. No. 11801071 ("Patent Rights").

WHEREAS, Assignee wishes to acquire all right, title and interest in the Patent Rights, and Assignors wishes to convey and release their interest in the Patent Rights to Assignee.

NOW THEREFORE, in consideration of the mutual promises, covenants, warranties, and other good and valuable consideration set forth herein, and in accordance with applicable law, the Parties hereby agree as follows:

1. **Assignment.** Assignors hereby assign to Assignee, and her successors, representatives and assigns, all right, title and interest in the Patent Rights including all reexaminations, extensions and reissues thereof. Assignors hereby request the Commissioner of Patents of the United States to record this assignment of all right, title and interest in the Patent to Assignee.
2. **Consideration.** Assignors and Assignee acknowledge and agree that sufficient consideration has been exchanged between them to effectuate this Assignment.
3. **Assignors' Representations and Warranties.** Assignors hereby represent and warrant as follows:
  - i) that they have the legal right and authority to execute this Agreement, and to validly assign the entire interest in the Patent Rights to Assignee,
  - ii) that they have not executed any other agreement that would conflict with the terms of this Agreement, nor shall it execute any such agreement in the future, and
  - iii) that to the best of Assignors' knowledge, the Patent Rights are valid and enforceable.
4. **Further Actions.** Assignors hereby agree to execute any further agreements and to take any further actions necessary to aid Assignee in perfecting her interest in the Patent Rights and in enforcing any and all protections or privileges deriving from the Patent Rights.
6. **Governing Law.** This Agreement shall be construed in accordance with, and governed in all respects by, the laws of the State of California without regard to conflicts of law principles.

7. **Counterparts.** This Agreement may be executed in several counterparts, each of which shall constitute an original and all of which, when taken together, shall constitute one agreement.

8. **Severability.** If any part or parts of this Agreement shall be held unenforceable for any reason, the remainder of this Agreement shall continue in full force and effect. If any provision of this Agreement is deemed invalid or unenforceable by any court of competent jurisdiction, and if limiting such provision would make the provision valid, then such provision shall be deemed to be construed as so limited.

9. **Notice.** Any notice required or otherwise given pursuant to this Agreement shall be in writing and mailed certified return receipt requested, postage prepaid, or delivered by overnight delivery service, addressed as follows:
