ASSIGNOR on behalf of itself and all predecessors in interest, has sold, assigned, transferred and set over, and by these presents does hereby sell, assign, transfer and set over, unto the said ASSIGNEE, its successors, legal representatives and assigns, (a) its entire right, title and interest, in, to and under such intellectual property listed in **Schedule A**; (b) all patents or patent application claiming the benefit therefrom, including all divisions, continuations, and continuations-in-part thereof; (c) all applications for industrial property protection, including, without limitation, all applications for patents, utility models, and designs which may hereafter be filed for said invention, together with the right to file such applications and the right to claim for the same the priority rights derived from said patent application under the Patent Laws of the United States, the International Convention for the Protection of Industrial Property, or any other international agreement or the domestic laws of the country in which any such application is filed, as may be applicable; (d) all forms of industrial property protection, including, without limitation, patents, utility models, inventors' certificates and designs which may be granted for the invention in any country, and all extensions, renewals and reissues thereof, all of the foregoing items to held and enjoyed by the ASSIGNEE, for its own use and behalf and the use and behalf of its successors, legal representatives, and assigns, to the full end of the term or terms for which Letters Patent or Patents may be granted as fully and entirely as the same would have been held and enjoyed by the ASSIGNOR had this sale and assignment not been made; (e) all income, royalties, damages and payments now and hereafter due or payable under or with respect to any of the foregoing, including damages and payments for past, present

ASSIGNOR, on behalf of itself and all predecessors in interest, HEREBY authorizes and requests the Commissioner of Patents and Trademarks of the United States, or other foreign authorities to issue the applicable intellectual property, to the ASSIGNEE, its or their successors, legal representatives and assigns, in accordance with the terms of this instrument.
