- (g) any and all refilings, divisions, continuations and continuations-in-part of the foreign-filed applications;

TO THE EXTENT PERMISSIBLE UNDER APPLICABLE LAW, ANY DISPUTE, CLAIM OR LITIGATION ARISING OUT OF OR RELATING IN ANY WAY TO THIS ASSIGNMENT SHALL BE RESOLVED IN ACCORDANCE WITH THE PURCHASE AGREEMENT.

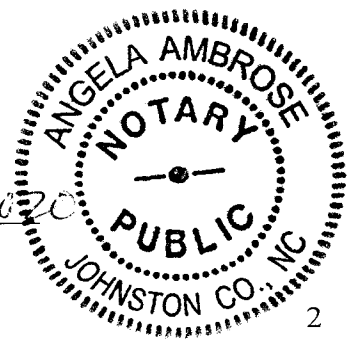
