PATENT ASSIGNMENT

THIS PATENT ASSIGNMENT ("**Assignment**") is made and entered into as of this 27th day of December, 2012, ("**Effective Date**"), by and between MIRROR LITE COMPANY, MIRROR LITE OF NORTH CAROLINA, INC., and IDEAL MOLDED LITE COMPONENTS, INC., (each an "**Assignor**", collectively the "**Assignors**"), and ROSCO, INC., a New York corporation, with its principal office at 90-21 144th Place, Jamaica, New York 11435-4397 ("**Assignee**"). Capitalized terms used but not defined herein have the meanings ascribed to such terms in the Purchase Agreement (defined below).

WHEREAS, at least one of the Assignors is the sole and exclusive owner of the entire right, title and interest in, to and under each of the United States patents listed on Schedule A, patent applications listed on Schedule B, respectively, and the foreign patents and patent applications listed on Schedule C (collectively the "**Patents**");

WHEREAS, Assignors, Assignee, Safety Cross Mirror, Inc. and William Schmidt have entered into that certain Asset Purchase Agreement, dated as of December 12, 2012 (the "**Purchase Agreement**"), the terms of which are incorporated herein by reference, which provides, among other things, for the sale and assignment by Assignors to Assignee of the Patents owned by Assignors; and

WHEREAS, Assignee wishes to acquire and Assignors wish to assign all right, title and interest in and to the Patents.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Assignors do hereby sell, assign, transfer and set over to Assignee, its legal representatives, successors and assigns, the entire right, title and interest in and to all inventions, developments, designs and/or subject matter as set forth in the Patents, and any modifications and/or improvements relating thereto (hereinafter "inventions"), and any additional inventions, developments, designs and/or subject matter relating to said invention (hereinafter "related inventions"), and to all of the rights and obligations relating thereto, for the United States and for all foreign countries, including any continuations, divisions, continuations-in-part, reissues, reexaminations, extensions or foreign equivalents thereof, and including the subject matter of all claims which may be obtained therefrom and any modifications and/or improvements relating thereto for its own use and enjoyment for the inventions and related inventions, and for the use and enjoyment of its successors, assigns or other legal representatives, and all rights to claim priority therefrom, as fully and entirely as the same would have been held and enjoyed by Assignors if this Assignment and sale had not been made; together with all income, royalties, damages or payments due or payable as of the Effective Date or thereafter, including, without limitation, all payments and claims for damages by reason of past, present or future infringement or other unauthorized use of the Patents, the inventions and the related inventions, with the rights to sue for, and collect the same for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives.

2. Assignors hereby authorize and request the Commissioner of the United States Patent and Trademark Office, and any official of any applicable country or countries foreign to the United States, whose duty is to issue patents or other evidence or forms of intellectual property or industrial property protection, to record Assignee as assignee and owner of the Patents.

3. Assignors shall provide Assignee, its successors, assigns or other legal representatives, cooperation and assistance at Assignee's request and expense (including the execution and delivery of any and all affidavits, declarations, oaths, exhibits, assignments, powers of attorney or other documentation as may be reasonably required): (1) in the preparation and prosecution of any applications covering the inventions assigned herein; (2) in the prosecution or defense of any interference, opposition, reexamination, reissue, infringement or other proceedings that may arise in connection with any of the patent rights assigned herein, including, but not limited to, testifying as to any facts relating to the patent rights assigned herein and this Assignment; (3) in obtaining any additional patent protection that Assignee may deem appropriate which may be secured under the laws now or hereafter in effect in the United States or any other country; and (4) in the implementation or perfection of this Assignment.

4. This Agreement is being executed solely to give effect to the transactions contemplated by the Purchase Agreement. Nothing in this Agreement, express or implied, is intended to or shall be construed to modify, expand or limit in any way the terms of the Purchase Agreement. To the extent any provision of this Agreement conflicts or is inconsistent with the terms of the Purchase Agreement, the Purchase Agreement shall govern.

5. Assignors shall execute and deliver such further instruments of assignment, conveyance and transfer and take such additional action as Assignee may reasonably request necessary to effect, consummate, confirm or evidence the assignment to Assignee of the Patents. Assignors will execute such documents as may be necessary or desirable to assist Assignee in preserving or perfecting its rights in the Patents as contemplated hereby or under the Purchase Agreement.

6. This Assignment may be executed in multiple counterparts, each of which shall be deemed an original, with the same effect as if the signatures thereto and hereto were upon the same instrument.

7. This Agreement shall be governed by and construed in accordance with the law of the state of Michigan applicable to contracts made and performed in such state, without regard to Michigan principles governing conflicts of law that would result in application of the laws of another state.
