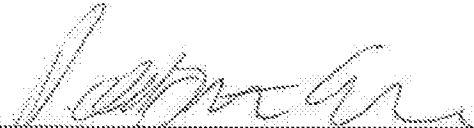
ASSIGNMENT

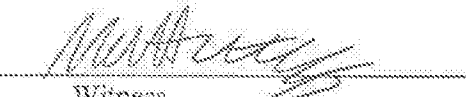

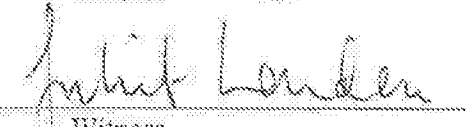
