ASSIGNMENT

WHEREAS, Commonwealth Scientific and Industrial Research Organisation ("CSIRO"), a corporation duly organized and existing under and by virtue of the laws of Australia and having a principal place of business at Limestone Avenue, Campbell, Australian Capital Territory, 2612, Australia, is the owner of the entire right, title and interest in and to U.S. Serial No. 13/918,392, filed June 14, 2013, claiming benefit of U.S. Provisional Application Nos. 61/782,680, filed March 14, 2013, 61/697,676, filed September 6, 2012, 61/663,344, filed June 22, 2012, and 61/660,392, filed June 15, 2012, entitled "PROCESS FOR PRODUCING ETHYL ESTERS OF POLYUNSATURATED FATTY ACIDS", and the invention disclosed therein by virtue of an assignment of rights from James Robertson Petrie, Surinder Pal Singh, and Robert Charles de Feyter to CSIRO (the "Patent Right"); and

WHEREAS, Grains Research and Development Corporation ("GRDC"), a corporation duly organized and existing under and by virtue of the laws of Australia and having a principal place of business at 1st Floor, 40 Blackall Street, Barton, Australian Capital Territory, 2600, Australia; and Nuseed Pty Ltd, a corporation duly organized and existing under and by virtue of the laws of Australia and having a principal place of business at 103-105 Pipe Road, Laverton, Victoria, 3028, Australia, are each entitled to own an equal, undivided right, title, and interest in and to the Patent Right as a tenant in common with CSIRO.

NOW, THEREFORE, in consideration of ONE DOLLAR (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, CSIRO, while retaining unto itself an equal undivided right, title, and interest in and to the Patent Rights as a tenant in common, hereby assigns and transfers to each of GRDC and Nuseed Pty Ltd and their lawful successors and assigns, an equal, undivided right, title, and interest in and to the Patent Rights as a tenant in common, as well as all other patent rights that may be based thereon, including all renewals, divisions, substitutes, reissues, continuations, reissues or extensions thereof, and every priority right that is or may be predicated upon or arise from the Patent Rights, to the full end of the term and any extensions thereof.

CSIRO hereby authorizes and requests all proper governmental authorities to issue all documents evidencing joint ownership, as tenants in common, of an equal, undivided right, title, and interest in and to the Patent Right to each of CSIRO, GRDC, and Nuseed Pty Ltd, and the lawful successors and assigns of each of them.
