RELEASE OF PATENT SECURITY INTEREST

This Release of Patent Security Interest ("Release") is given on this 21st day of March 2018, by JPMORGAN CHASE BANK, N.A. (the "Grantee"), to DELUXE CORPORATION (the "Grantor"), as follows:

WHEREAS, the Grantor has satisfied its obligations under the Security Agreement and the Confirmatory Grant (including all conditions for release), and the Grantee wishes to release its security interest in the Patents, including those listed on Schedule A and retransfer and reassign to the Grantor without recourse all of the Grantee's right, title and interest in and to the Patents.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby (i) terminates the Confirmatory Grant and releases any security interest, right or other interest it may have in the Patents, including those listed on Schedule A, and hereby reassigns any and all right, title and interest it may have in and to the Patents without recourse to the Grantor and (ii) agrees to execute, acknowledge, procure and deliver to Grantor, at Grantor's expense, any and all further documents or instruments and do any and all further acts which the Grantor (or its respective agents, designees or assignees) reasonably request in order to confirm, effectuate or record this Release and Grantor's (or their assignees') right, title and interest in and to the Patents.
