- (iv) the right to claim priority under any national, regional or international treaty from the Applications and from any other application for intellectual property rights in respect of the invention and improvements.


The Assignor hereby authorizes and requests the Commissioner of Patents or other like authority in each respective country to issue said Letters Patents to said Assignee its successors and assigns.
