## ASSIGNMENT

Be it known that, for and in consideration of the sum of One Dollar (\$1.00) lawful money of the United States, to us in hand paid, the receipt of which is hereby acknowledged, and for other good and valuable considerations, the receipt and sufficiency of which the parties acknowledge, the Assignors, hereby sell, assign, transfer, set, convey, grant, and relinquish exclusively to the Assignee, free and clear of any and all pledges, liens, security interests, or any other encumbrance of any kind whatsoever, all the right, title, and interest in and to the Invention and the Application, as well as such rights in any and all continuations, divisions, in whole or in part or substitute applications, and including, not limited to, any Letters Patent of the United States and of foreign countries that may be granted for the Invention for the entire term of such Letters Patent, including all rights under the International Convention and Treaties, and any renewal, any reissue, and any extension of any such Letters Patent; the same to be held and enjoyed by the Assignee, its successors, legal representatives, and assigns, as fully and entirely as the same would have been held and enjoyed by the Assignors if this assignment and sale had not been made; and the Assignors hereby represent, covenant and warrant that the Assignors have the full right and authority to convey the entire interest herein assigned, and that the Assignors

have not executed and will not execute any instrument purporting to convey, option, mortgage, lease, license, or otherwise transfer or encumber all or any part of the entire right, title, and interest to anyone other than the Assignee, its successors, legal representatives, and assigns.

The Assignors authorize and request the Commissioner of Patents of the United States to issue any Letters Patent which may be granted upon the aforesaid Application or applications to the Assignee. The Assignors further authorize the Assignee, its successors and assigns, or anyone it may properly designate, to apply for Letters Patent, in its own name, if desired, in any and all foreign countries, and additionally to claim the filing date of the United States application and/or otherwise take advantage of the provisions of the International Convention and Treaties.

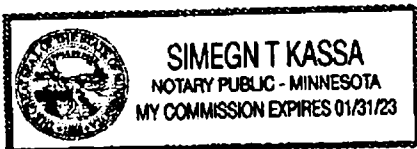

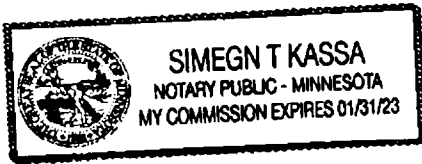

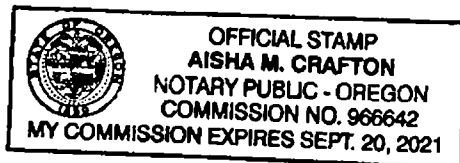
