### **ASSIGNMENT**

The Assignor sells, assigns, and transfers the entire right, title, and interest to the Assignee as of the earliest day of filing of any of the application identified above.

The Assignor covenants and agrees, for both the Assignor and the Assignor's legal representatives, that the Assignor will assist the Assignee in the prosecution of the patent applications identified above; in the making and prosecution of any other patent applications that the Assignee may elect to make covering the invention identified above; in vesting in the Assignee exclusive title in all such other patent applications and patents; and in the prosecution of any interference which may arise involving the invention, or any such patent application or patent; and that the Assignor will execute and deliver to the Assignee all additional papers that may be requested by the Assignee to carry out the terms of this Assignment.
