ASSIGNMENT

WHEREAS, WE, Darren S. Sheedy, a citizen of the United States of America, residing at 1860 Old Sinking Creek Rd., Greenback, Tennessee 37742, Ryan D. Lake, a citizen of the United States of America, residing at 1485 Niles Ferry Road, Madisonville, Tennessee 37354, and David F. Ekern a citizen of the United States of America, residing at 824 W. NOW, THEREFORE, WE hereby acknowledge that we have sold, assigned, transferred and set over, and by these presents do hereby sell, assign, transfer and set over, unto said MasterCraft Boat Company, LLC, its successors, legal representatives, and assigns, the entire right, title and interest in, to, and under said invention, together with said application and any and all later-filed applications based thereon, including divisions, renewals, and continuations, and all Letters Patent of the United States which may be granted on such applications, and all reissues and extensions thereof, and all applications for Letters Patent or Certificate of Invention which may hereafter be filed for said invention in any country or countries foreign to the United States, and all Letters Patent and Certificates of Invention that may be granted for said invention in any country or countries foreign to the United States, and all extensions, renewals, and reissues thereof, and all rights of priority in any such country or countries based upon the filing of said applications for Letters Patent of the United States which are created by any law, treaty, or international convention; and we hereby authorize and request the Commissioner of Patents and Trademarks of the United States, and any official of any country or countries foreign to the United States whose duty it is to issue Letters Patent or Certificates of Invention on applications

as aforesaid, to issue all Letters Patent and Certificates of Invention for said inventions to MasterCraft Boat Company, LLC, its successors, legal representatives, and assigns, in accordance with the terms of this instrument.

AND WE HEREBY consent that a copy of this assignment shall be deemed a full and formal equivalent of any assignment, consent to file, or like document which may be required in any country or region for any purpose, and more particularly in proof of the right of our assignee or its nominees to claim the aforesaid benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it.

AND WE HEREBY covenant that we have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute, any agreement in conflict herewith.

AND WE HEREBY further covenant and agree that we will communicate to said MasterCraft Boat Company, LLC, its successors, legal representatives, and assigns, any facts known to me respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing, and reissue applications, make all rightful oaths, and generally do everything possible to aid MasterCraft Boat Company, LLC, its successors, legal representatives, and assigns, to obtain and enforce proper Letters Patent or Certificate of Invention protection for said invention in all countries.
