**TERMINATION AND RELEASE OF
SECURITY INTEREST IN PATENTS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS (the "*Termination and Release*") dated as of April 4, 2018 from CAPITAL ONE BUSINESS CREDIT CORP., as successor collateral agent (the "*Collateral Agent*") pursuant a Patent Security Agreement dated as of July 17, 2014 (the "*Security Agreement*") between ATRENNE COMPUTING SOLUTIONS, LLC (formerly known as CBT Technology, LLC), a Delaware limited liability company (as "*Grantor*") and CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH (the "*Predecessor Agent*"), as assigned to the Collateral Agent pursuant to a Notice of Assignment of Patent Security Agreement dated as of November 6, 2014 (the "*Notice of Assignment*").

WITNESSETH:

WHEREAS, pursuant to the Security Agreement a security interest (the "*Security Interest*") was granted by the Grantor to the Predecessor Agent in certain collateral, including the Specified Patent Collateral (as hereinafter defined) and such Security Interest and the Security Agreement were assigned to the Collateral Agent pursuant to the Notice of Assignment;

WHEREAS, the Security Agreement was recorded in the Patent Division of the United States Patent and Trademark Office on September 22, 2014 at Reel 033784, Frame 0378;

WHEREAS, the Notice of Assignment was recorded in the Patent Division of the United States Patent and Trademark Office on November 10, 2014 at Reel 034196, Frame 0311; and

WHEREAS, Grantor requests and the Collateral Agent is willing to terminate and release its Security Interest in the Specified Patent Collateral as specified herein;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:


1. Definitions. The term "*Specified Patent Collateral*", as used herein, shall mean the Patent Collateral (as defined in the Security Agreement), including, without limitation, each patent registration and application set forth on Schedule I hereto.

2. Release of Security Interest. The Collateral Agent hereby terminates, releases and discharges its Security Interest in the Specified Patent Collateral without representation, warranty or recourse of any kind or nature.
