RELEASE OF PATENT SECURITY AGREEMENT

This RELEASE OF PATENT SECURITY AGREEMENT ("Release"), effective as of February 26, 2018, given by **CORTLAND CAPITAL MARKET SERVICES LLC**, as Collateral Agent ("Agent") to **NIXON, INC.**, a California corporation (the "Pledgor").

W I T N E S S E T H

WHEREAS, pursuant to that certain Amended and Restated Credit Agreement, dated as of May 12, 2017 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), the Lenders (as defined in the Credit Agreement) have agreed to make certain financial accommodations to the Borrower (as defined in the Credit Agreement);

WHEREAS, in connection with the Credit Agreement, the Pledgor executed that certain Amended and Restated Security Agreement, dated as of May 12, 2017 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement") and granted to the Agent a continuing priority security interest in and to all Pledgor's right, title and interest in all the Patents of the Pledgor, including as set forth on Schedule A attached hereto (collectively, the "Patents") to secure the Secured Obligations (as defined in the Credit Agreement);

WHEREAS, in furtherance of the Security Agreement, the Pledgor executed a Patent Security Agreement, dated May 17, 2017 (the "Patent Security Agreement"), which was duly recorded on May 17, 2017, at Reel 042487 Frame 0976 in the United States Patent and Trademark Office;

WHEREAS, the Agent wishes to release and restore all right, title and interest in and to the Patents to the Pledgor and to dissolve those Liens (as defined in the Credit Agreement) and encumbrances created by the Patent Security Agreement and the Security Agreement in respect of the Patents.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby grants, assigns and conveys, without recourse or warranty, to the Pledgor all of its rights, title and interest in the Patents, and terminates, releases, discharges, quitclaims and relinquishes unto the Pledgor any and all security interests or liens it has against the Patents.
