2. Enjoining e.Digital Corporation, and anyone acting on behalf of e.Digital

Corporation, from manufacturing, using, selling, and licensing The Patents under the rescinded Consulting & Non-Disclosure Agreement and Patent Assignments;

3. For an order of this Court declaring and providing for Patrick Nunally's ability and authority to exercise exclusive ownership and control of The Patents, including all right, title and interest in and to The Patents and application and to all foreign counterparts (including patent, utility model and industrial designs), and in and to any Letters Patent and Registrations which may hereafter be granted on the same in the United States and all countries throughout the world, and to claim the priority from the application as provided by the Paris Convention; and
4. For compensatory damages, payable to Patrick Nunally, in an amount equal to \$225,000.00, calculated as follows:
  - a. For unpaid royalties: \$2,500.00 per month for each of The Patents (14 patents total = \$35,000.00 per month), from June 2017 to November 1, 2017, totaling \$175,000.00 in unpaid royalties as of November 16, 2017.
  - b. For unpaid compensation: \$15,000 for May 2017, totaling \$15,000.00.
