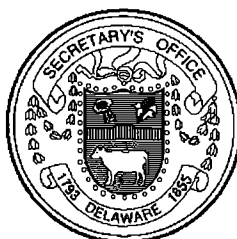

1.


The name of the corporation is AT&T BLS Intellectual Property, Inc.
