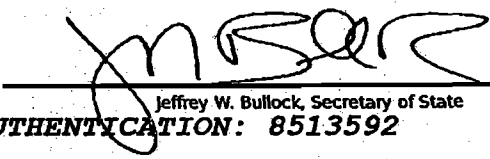

FIRST: The name of the Company is "Ardian, Inc."

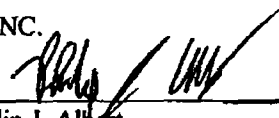
SECOND: The Company was initially incorporated in the State of Delaware on October 8, 2003.
