AND Assignor hereby authorizes and requests the Commissioner of Patents of the United States Patent & Trademark Office, and any official of any country foreign to the United States whose duty it is to issue patents, to issue any patent and any reissues and extensions thereof to the Assignee in accordance with this Assignment;

AND Assignor hereby grants to the Assignee the full right to sue for and recover all

profits and damages recoverable for past infringement of the invention, the patent application, and any U.S. and/or foreign patent applications or patents that may be obtained for the invention, for Assignee's use and behalf and for the use and behalf of Assignee's successors, assigns and other legal representatives;
