DEED OF ASSIGNMENT

This Assignment is made on 08 March 2018

BETWEEN

Ronald Lek Shao Hui whose registered address is at c/o 65 UBI AVENUE 1, SINGAPORE 408939
(the Assignor); and

OSIM International Pte Ltd whose registered office is at 65 Ubi Avenue 1, OSIM Headquarters,
Singapore 408939 (the *Assignee*)

DEFINITIONS:

In this Assignment the following expressions shall have the following meanings:

Articles	articles in respect of which the Design has been applied, including the components intended to be assembled into the said articles and any such modifications or improvements which may be made to the said design;
Assignment	means this Deed of Assignment and any schedules attached hereto;
Design	the design[s] of which particulars are set out in Schedule A , including any such modifications or improvements which may be made to the said design;
Information	all data, know-how or knowledge regarding and relating to the materials and manufacturing techniques of the Articles, and all other information relating to the materials, manufacturing techniques and other information necessary to manufacture the Articles properly, efficiently and in reasonable quantities

Intellectual Property means all copyrights, moral rights, related rights, patents, utility models, trade marks, design rights, rights in undisclosed or confidential information (such as know how, trade secrets and inventions (whether patentable or not)) and other similar intellectual property rights (whether registered or not) and applications for such rights in the Design, as may exist anywhere in the world, and shall include, without limitation, the design applications/registrations as set out at Schedule B and the Information.

Undertaking Deed of Undertaking executed by the Assignor dated [7 March 2018]

RECITAL:

The Assignor has, pursuant to the Undertaking, agreed to assign and transfer to the Assignee all rights, title and interest in the Intellectual Property including all know how and confidential information relating to the Design as is in the possession of the Assignor upon the terms and conditions set out below.

TERMS:

1. In consideration of the sum of SGD10.00 now paid by the Assignee to the Assignor, the sufficiency and receipt of which the Assignor hereby acknowledges, the Assignor hereby assigns and transfers to the Assignee:

1.1 all rights, title and interest in the Design and all Intellectual Property subsisting therein, and the full and exclusive benefit thereof and all rights privileges and advantages appertaining thereto;

1.2 any unregistered rights including without limitation design rights subsisting in the Design;

1.3 all rights and title possessed by the Assignor in respect of the Information and the full unfettered and exclusive worldwide right to use the Information for any purpose whatsoever (including the filing of patent or design applications in respect of all or an aspect of it),

TOGETHER WITH the right to take all such proceedings as may be necessary or other forms of relief, in respect of all infringements of the Intellectual Property whether taking place before or after the date of this Assignment **AND ALL** the benefit of the aforesaid Intellectual Property to the intent that any applications filed or registrations granted thereon shall become the property of the Assignee and **TO HOLD** the same unto the Assignee absolutely;

2. The Assignor hereby covenants with the Assignee to:

2.1 disclose all the Information known to the Assignor to the Assignee;

2.2 provide all reasonable assistance and information as may be necessary in order to assist the Assignee to develop and manufacture the Articles; and

2.3 at the expense of the Assignee, and upon request, execute, sign and do all such instruments applications, documents acts and things as may be required by the Assignee (or the nominee of the Assignee) to enjoy the full benefit of the property and rights hereby assigned throughout the world and to fully and effectively vest the same in the Assignee or as the Assignee shall direct.

3. The Assignor further undertakes to deliver to the Assignee all documents and materials relating to the Design or the Information, or which are necessary to use and/or exploit the Intellectual Property subsisting therein, including but not limited to all documents, drawings, notes or memoranda relating to the Design and the Information.

4. The Assignor warrants, represents and undertakes that he:

4.1 is the sole designer and owner of the Design and the Intellectual Property subsisting therein and has full power to enter into this Assignment;

4.2 has not knowingly by his act or omissions, done anything to imperil the validity of any Intellectual Property subsisting in the Design; and

4.3 has not entered into any agreement, either written or oral, which conflicts with the terms of this Assignment.

5. The Assignor agrees that this Assignment shall survive the termination, expiry or end of the Employee's employment with the Company and the assignment of this Assignment by the Assignee to any successor in interest or other assignee.
6. This Assignment is governed by the laws of Singapore and any dispute between the parties in relation to it shall be subject to the exclusive jurisdiction of the courts in Singapore.
