Assignor hereby authorizes and requests the United States Commissioner for Patents and the officials empowered to record Assignee as the assignee and owner of said patents and pending applications and to issue patents in countries foreign to the United States of America, to issue any and all Letters Patent of the United States and foreign countries on said inventions or resulting from said applications or any divisionals, renewals, reissues, reexaminations, extensions, continuations, or continuations-in-part thereof to said Assignee, as assignee of the entire interest, and hereby represents, warrants, and covenants that it has full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreement in conflict herewith.
