- (a) all right, title and interest in the United States of America and Canada and in the world, in, to and under said Patents and any registration issuing thereunder and any other patents for such Inventions;
- (b) the right to file additional patent applications in any country for said Inventions, and to do so in its own name (hereinafter “**Additional Applications**”);
- (c) all right, title and interest in the United States of America and in Canada and in the world in any and all existing or future substitute, divisional, continuation or continuation-in-part patent applications deriving directly or indirectly either in whole or in part from such Patents or such Inventions and any of such Additional Applications (hereinafter “**Derivative Applications**”);
- (d) all right, title and interest in the United States of America and in Canada and in the world, in, to and under all patents granted directly or indirectly on or as a result of the Patents, any of such Additional Applications and any of such Derivative Applications, and any reissues, renewals or extensions thereof;
- (e) the right to claim benefits available in any country under the *International Convention For The Protection of Industrial Property*, and any like treaties or laws;

- (f) the right to claim and to the benefit of any priority dates established by the Inventions or the Patents;
- (g) all income, royalties, damages, profits and payment now or hereafter due or payable with respect to the Inventions or Patents; and
- (h) all causes of action and the right to sue, counterclaim and recover, for past, present and future infringement or unauthorized use of the rights and interest assigned under this Memorandum of Assignment,

the same to be owned, held and enjoyed by the Assignee, its successors, assigns and legal representatives, as fully and exclusively as it would have been held and enjoyed by the Assignor had this sale, assignment and transfer not been made.



THE ASSIGNOR hereby agrees that this assignment shall be binding upon its successors, assigns and legal representatives;

AND THE ASSIGNOR hereby covenants and agrees to do all such things and to execute or obtain execution without further consideration of such further lawful documents, assurances, applications and other instruments as may be reasonably required to make and prosecute and defend any and all patent applications in the United States of America and in Canada and in the world on said Inventions, to enforce any patents arising from or out of the Inventions, the Patents and any and all patents in the United States of America and Canada and in the world on said Inventions, and to confirm in the Assignee or its successors and assigns, legal title in the United States of America and Canada and in the world to said Inventions, the Patents, all Derivative Applications and Additional Applications and all United States patents and United States applications, Canadian patents and Canadian patent applications and any corresponding patents and applications anywhere in the world, on said Inventions. The Assignee will reimburse the Assignor for reasonable costs and expenses incurred related to prosecuting, enforcing and defending the Patents and any Derivative Applications.

THE ASSIGNOR hereby acknowledges that following this Assignment it retains no rights, title or interest in the Inventions and hereby waives any rights the Assignor may have to challenge the validity and effectiveness of this Memorandum of Assignment in whole or in part.
