WO 2014011053 and WO 2014011050 and including without limitation those listed in "Appendix A" (collectively, "Patent Applications"), patent applications to which said Patent Applications claim the benefit of, or priority thereto, and any patent applications claiming the benefit of, or priority to said Patent Applications, and any and all Letters Patent(s) issuing therefrom (collectively, "Patent Rights");

WHEREAS, on June 29, 2015, ProQR Therapeutics N.V., entered into demerger within the meaning of Section 2:334a(3) of the Dutch Civil Code by deed of demerger ("Demerger"), in which (i) ProQR Therapeutics I B.V. (CR No. 63634511), (ii) ProQR Therapeutics II B.V. (CR No. 63634538), (iii) ProQR Therapeutics III B.V. (CR No. 63634546), and (iv) ProQR Therapeutics IV B.V. (CR No. 63634554) became incorporated upon June 6, 2015;

WHEREAS, pursuant to the Demerger, ProQR Therapeutics N.V. transferred certain assets to ProQR Therapeutics I B.V., ProQR Therapeutics II B.V., ProQR Therapeutics III B.V. and ProQR Therapeutics IV B.V.; and

WHEREAS, ProQR Therapeutics N.V. and ProQR Therapeutics II B.V. now wish to confirm the transfer of certain assets from ProQR Therapeutics N.V. to ProQR Therapeutics II B.V.;

NOW, THEREFORE, to all whom it may concern be it known that for and in consideration of one EURO and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ProQR Therapeutics N.V. confirms that it sold, assigned and transferred and by these presents does hereby sell, assign and transfer to ProQR Therapeutics II B.V. (address: Darwinweg 24, 2333 CR Leiden) its entire right, title and interest in and to the said Patent Rights, including the invention(s) described therein, and any patent applications that claim the benefit of or priority to said Patent Applications under United States law or international convention, including but not limited to continuations, continuations-in-part, divisionals, reissues, reexaminations, extensions, and substitutions, and any and all Letters Patent(s) as may issue from any of the foregoing.
