

This assignment assigns the right to claim priority to any previously filed provisional or utility application noted herein, as well as the right to be granted a patent in PCT Contracting States.

And I hereby authorize and request the Commissioner of Patents and Trademarks to issue said United States Letters Patent to said **Häfele Berlin GmbH & Co KG**, as the assignee of the whole right, title, and interest thereto.


