Inventor hereby consents that a copy of this Assignment and Agreement shall be deemed a full legal and formal equivalent of any document which may be required in any country in proof of the right of Life Spine to apply for patent or other form of protection for said inventions and to claim the aforesaid benefits of the right of priority.

Inventor requests that any and all patents for said inventions be issued to Life Spine in the United States and in all countries foreign to the United States or to such nominees as Life Spine may designate.

Inventor agrees that, when requested, I shall, without charge to Life Spine, but at its expense, sign all papers, and do all acts which may be necessary, desirable or convenient in connection with said applications, patents, or other forms of protection.
