RECITALS :

- (A) The Assignors are co-inventors of Invention ("the Invention") described in the United Kingdom patent application details of which are set out in the Schedule hereto and forms part of this assignment ("the Applications"); and
- (B) The Assignors have agreed to assign all rights, title, interest and property in the Applications and Invention to the Assignee, together with all ancillary rights relating thereto upon the following terms.

OPERATIVE PROVISIONS :

1. In consideration of the sum of £1.00 paid by the Assignee to the Assignors, the receipt and sufficiency of which is hereby acknowledged, the Assignors hereby assign :
 - i) all rights, title and interest and property in the Applications and the Invention, free from all licenses, charges and other encumbrances, with full title guarantee;
 - ii) the right to apply for and to obtain patents or other form of protection in respect of the whole or any part or parts of or improvements to the invention worldwide ("Further Applications") and/or obtain other forms of protection to the intent that those Further Applications and other forms of protection shall be in the name and shall vest in the Assignee;
 - iii) the full and exclusive benefit of the Applications, the Invention and Further Applications, and other forms of protection and all rights, privileges and advantages appertaining thereto, together with the right to obtain any extensions and supplementary protection certificates;
 - iv) the right to recover and to bring proceedings to recover damages and/or to obtain other remedies in respect of infringement of any patents and other forms of protection relating to the invention whether committed before or after the date of this assignment;
 - v) the right to claim priority from the Applications or Further Applications under the terms of the International convention and any treaties; and
 - vi) the right to file divisional applications and continuations of the Applications and Further Applications;

TO HOLD the same unto the Assignee absolutely.

2. At the request and cost of the Assignee, the Assignors will execute and sign all such instruments, applications, deeds, documents and do all such acts and things as may be reasonably required by the Assignee to enable the Assignee or its nominee to: (a) enjoy the full and exclusive benefit of the Applications and the Invention and of the property rights hereby assigned, (b) fully and effectively vest the same in the Assignee, (c) formally register the Assignee's title in the same at any relevant Patent Office, and (d) assist in the prosecution of all national and regional applications to grant.
3. The Agreement shall be binding upon and shall inure to the benefit of the parties hereto, their respective successors and assigns as well as any subsidiary

companies of the parties hereto.

4. The parties will co-operate and consult with one another in good faith, if necessary in the future to carry out the intent of this agreement.
5. This agreement shall be governed by and construed in accordance with the laws of England and Wales and the parties for this purpose hereby submit to the exclusive jurisdiction of the Courts of England and Wales.
