
**TERMINATION AND RELEASE OF SECURITY INTEREST
IN PATENTS**

WHEREAS, GreenRoad Driving Technologies Ltd., a company incorporated in Israel (the "Company") entered into a U.S. Intellectual Property Security Agreement, dated May 15, 2014 (as from time to time amended, modified or supplemented, the "Security Agreement") by the Company in favor of Kreos Capital IV (Expert Fund) Limited ("Kreos"), pursuant to which the Company granted a security interest (the "Security Interest") in all of the Company's right, title and interest in and to the Patents (as defined in the Security Agreement), including without limitation the patents and patent applications set forth on the attached Schedule A, all to the extent set forth in the Security Agreement; and

WHEREAS, all of the secured obligations have been fully paid and satisfied and Kreos desires to release the Security Interest.

NOW THEREFORE, in consideration of the foregoing and intending to be legally bound, Kreos hereby releases the Security Interest in the Patents listed on Schedule A annexed hereto, and hereby, (i) waives and relinquishes all its rights, powers, privileges and remedies under the Security Agreement with respect to the Patents, (ii) assigns, conveys, transfers and sets over to the Company any right, title or interest that Kreos may have acquired and re-vests in the Company the full unencumbered title to the Patents and the goodwill associated therewith, and (iii) releases the Company from all covenants, obligations, liabilities and warranties under the Security Agreement related to the Patents.
