EMPLOYEE AGREEMENT

In consideration of my employment by Ciba Specialty Chemicals Corporation (hereinafter Ciba), and the salary or other compensation to be paid for my services during my employment by Ciba, I agree as follows:

3. Intellectual Property.

b. Ownership of Intellectual Property.

- (i) If, during my employment with Ciba, or within six (6) months after termination of my employment, I make, develop or conceive, solely or jointly with another, any idea, invention, discovery, work of authorship or improvement (patentable or not) which is related to Ciba's business are, or I make, develop or conceive any idea, invention, discovery work of authorship or improvement during work hours and/or while using Ciba's equipment, supplies, facilities or confidential information (regardless of its relationship to Ciba's business area), I agree that at all rights of ownership in any such idea, invention, discovery, work of authorship or improvement, all patents, patent applications, copyrights, trademarks and records relating thereto, shall be the exclusive property of Ciba. All ideas, inventions, discoveries, work of authorship and improvements governed by this Section 3(b) shall hereafter be referred to as "Intellectual Property."

c. **Cooperation Concerning Intellectual Property** . In connection with all Intellectual Property which is the property of Ciba under Section 3(b) of this agreement, I will, at Ciba's expense: (i) Keep full and accurate records regarding all such Intellectual Property, (ii) promptly disclose all such Intellectual Property to Ciba, (iii) promptly execute, on Ciba's request, a specific assignment of title of Ciba or Ciba's designee, (iv) do anything else reasonably necessary to enable Ciba or Ciba's designee to secure a patent, copyright trademark or other form of protection in the United States and in other countries, and (v) execute any instruments necessary or which Ciba may deem desirable in connection with any continuations, divisions, continuation-in-part, renewals or reissues of said patent or any matters relating to copyright matters and other forms of protection or any resulting litigation in regard thereto, The obligations contained in this Section 3(c) shall continue after termination of my employment with Ciba.
