(f) any and all United States and foreign patents which shall issue on said Inventions or from any of the above-identified applications ((a) - (e)) including all reissues, reexaminations, renewals, divisions, continuations, and extensions thereof, for the United States, its territories and possessions and all foreign countries, regional and international patent offices, including the right to file applications for Letters Patent on said Inventions, and any of the aforementioned applications (in (a) -- (e)) in any and all foreign countries and any other patent office, and every priority right that is or may be predicated upon or arise from said Inventions or said aforementioned application, and the right to sue for past infringements, the same to be held and enjoyed by said Assignee, its assigns and

successors, as fully and entirely as the same would have been held and enjoyed by me, had this Assignment and sale not been made.

AND for the same consideration, Assignors hereby represent and warrant to Assignee, its successors, legal representatives and assigns, that, at the time of execution and delivery of these presents, except for any rights, titles and/or interests that have arisen to Assignee under law or that have already been transferred to Assignee, Assignors are the sole and lawful owner of the entire right, title and interest in and to the said Inventions and said applications for Letters Patent above-mentioned, and that the same are unencumbered and that Assignor has good and full-right and lawful authority to sell and convey the same in the manner herein set forth.

AND for the same consideration, Assignors hereby covenant and agree to and with Assignee, its successors, legal representatives and assigns, that Assignors will sign all papers and documents, take all lawful oaths and do all acts necessary or required to be done for the procurement, maintenance, enforcement and defense of any Letters Patents and applications for Letters Patent for said Inventions, without charge to Assignee, its successors, legal representatives and assigns, whenever counsel of Assignee, or counsel of its successors, legal representatives and assigns, shall advise: that any proceeding in connection with said Inventions, or any proceeding in connection with any Letters Patents or applications for Letters Patent for said Inventions in any country or patent office, including but not limited to interference proceedings, is lawful and desirable; or, that any division, continuation or continuation-in-part of any application for Letters Patent, or any reissue, reexamination or extension of any Letters Patent, to be obtained thereon, is lawful and desirable.

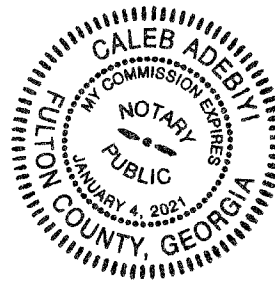

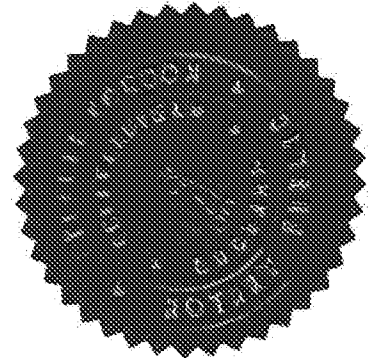
