PATENT ASSIGNMENT

BE IT KNOWN, that for and in consideration of the sum of money to the Seller in hand paid or to be paid by the Buyer, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Seller, by these presents has sold, assigned, transferred and set over, and does hereby sell, assign, transfer and set over, to the Buyer, all of the Seller's right, title and interest to the Patent Property, and to any and all inventions described in the Patent Property for the United States, and its territorial possessions; the same to be held and enjoyed by the Buyer for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives, to the end of the term or terms for which Letters Patent have been or may be granted or reissued, as fully and entirely to the same extent as the same would have been held and enjoyed by the Seller if this assignment and sale had not been made; together with all claims for damages or injunctive relief by reason of infringements of such Letters Patent listed in the Patent Property, with the right to sue for past infringement, and collect the same for its own use and behalf for the use and behalf of its successors, assigns or other legal representatives.

And the Seller hereby authorizes and requests the governing body of the pertinent country or region to issue any and all Letters Patent of the pertinent country or region on such inventions or resulting from the Patent Property to the Buyer, as assignee of the Seller's interest.



