**THIRD:** The name of the surviving corporation is **BT AMERICAS INC.**, a Delaware corporation.

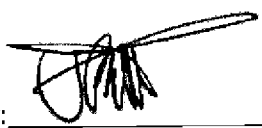
**FOURTH:** The Certificate of Incorporation of the surviving corporation shall be its Certificate of Incorporation.
