AND ASSIGNORS HEREBY further covenant and agree that ASSIGNORS will communicate to the ASSIGNEES, their successors, legal representatives and assigns, any facts known to ASSIGNORS respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all continuing and subsequent applications, including divisional, reissue and foreign applications, make all rightful oaths, and generally cooperate and do everything possible to aid the ASSIGNEES, their successors, legal representatives and assigns, to obtain, maintain, and enforce proper protection for said invention in any and all countries.

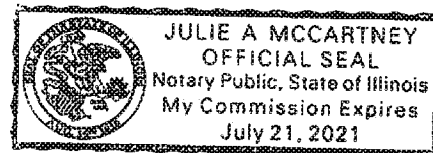
