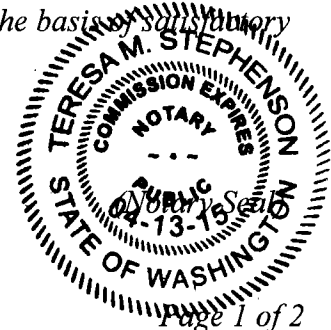

THIS MATTER having come before the Court upon the Plan Administrator's (the "PA's") Motion (the "Motion") for entry of an Order Approving Sale of Lot 52 of Patent-Related Assets to Nest Labs, Inc. or Other Prevailing Bidder Under Proposed Bidding Procedures (the "Bid Procedures"); and the Court having duly considered the Motion with all the supporting declarations, the responses thereto, as well as the arguments of counsel, and the Court having determined that the PA's proposed Bid Procedures outlined in the Motion are adequate and fair¹; and the Court having determined that the all-cash purchase offer submitted by Nest Labs, Inc., as compared to the purchase offer submitted by the Debtor, is of greater

2 having determined that the notice given of the Motion was sufficient and appropriate under
3 the circumstances; and the Court having made its findings of fact and conclusions of law as
4 set forth in its oral ruling at the conclusion of the September 14, 2012 hearing on the Motion,
5 which findings of fact and conclusions of law are incorporated herein pursuant to Federal
6 Rule of Civil Procedure 52 and Federal Rules of Bankruptcy Procedures 7052 and 9014; now,
7 therefore it is hereby ORDERED as follows:

8 1. The sale of the eight (#2) Energy Conservation U.S. Patent 8,033,479;
9 7,168,627; 8,014,902; 8,020,777; 7,455,237; 7,163,156; 7,156,316 and 7,455,236, and all the
10 foreign applications, abandoned U.S. applications and the pending U.S. applications, as
11 identified on Exhibit A attached hereto (collectively, "Lot 52"), to Nest Labs, Inc. for the
12 purchase price of \$118,000 (the "Purchase Price") is in the best interests of the Estate, and is
13 hereby approved.

14 2. Nest Labs, Inc. is required to submit the Purchase Price, and any other
15 payments required under the Auction Consignment Agreement, no later than three days from
16 the expiration of the 14-day stay provision under Bankruptcy Rule 6004(h).

17 3. The PA is authorized to take any further action necessary for the
18 consummation of the sale, including, without limitation, the transfer and assignment of all
19 rights in Lot 52 to Nest Labs.

20 4. The sale of Lot 52 to Nest Labs is determined to be a sale to a good faith
21 purchaser, free and clear of any interests in Lot 52, pursuant to 11 U.S.C. §§363(b), (f) and
22 (m).
