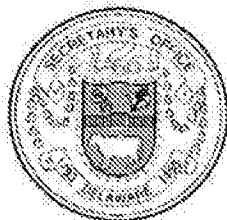

Pursuant to Section 252 of the General Corporation Law of the State of Delaware, as amended from time to time, the undersigned surviving corporation submits this Certificate of Merger for filing and certifies that:

I.

The names and states of incorporation of the merging corporations are Andritz Paperchine Inc., a Delaware corporation, the merged corporation, and Andritz Inc., a Georgia corporation, the surviving corporation (the "Constituent Corporations").

II.

The Agreement and Plan of Merger dated as of March 31, 2018, was duly approved, adopted, certified, executed and acknowledged by each of the Constituent Corporations in accordance with Section 252 (and, with respect to Andritz Paperchine Inc., by the written consent of its sole stockholder) of the General Corporation Law of the State of Delaware (the "DGCL").

III.

The name of the surviving corporation is Andritz Inc.

IV.

The articles of incorporation of Andritz Inc. at the Effective Time (as defined below) shall be the articles of incorporation of the surviving corporation and shall continue in full force and effect until changed, altered or amended.

V.

The executed Agreement and Plan of Merger is on file at the principal place of business of the surviving corporation, which is located at 5405 Windward Parkway, Suite 100W, Alpharetta, Georgia 30004.

VI.

A copy of the executed Agreement and Plan of Merger will be furnished by the surviving corporation, on request and without cost, to any stockholder of any Constituent Corporation.

VII.

Pursuant to Section 252(d) of the DGCL, Andritz Inc. hereby agrees that it may be served with process in the State of Delaware in any proceeding for the enforcement of any obligation of Andritz Paperchine Inc., as well as for enforcement of any obligation of Andritz Inc. arising from the merger, including any suit or other proceeding to enforce the right of any stockholders as determined in appraisal proceedings pursuant to the provisions of Section 262 of the DGCL, and hereby irrevocably appoints the Secretary of State of the State of Delaware

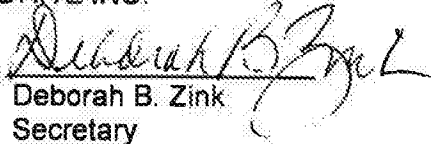
VIII.
