NOW, THEREFORE, for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR does hereby sell, transfer, and assign unto the ASSIGNEE, its successors, assigns and other legal representatives, for the territory of the United States of America and throughout the world, its right, title and interest in and to the inventions and improvements that are the subject of the PATENT APPLICATIONS; this ASSIGNMENT including the PATENT APPLICATIONS, together with any and all reissues, reexaminations, statutory invention registrations, modifications and extensions thereof, together with any and all continuations, divisionals, continuations-in-part, and all of the inventions and improvements relating to the foregoing, and including the right to claim priority, and hereby authorizes and requests the Commissioner of Patents for the country involved to issue any and all patents on inventions resulting from the PATENT APPLICATIONS or other applications claiming priority/benefit on the PATENT APPLICATIONS to ASSIGNEE as assignee of the entire right, title and interest therein the rights of inventor, Christopher Scott Perry, having previously been assigned to ASSIGNEE, all of the foregoing to be held and enjoyed by ASSIGNEE for its own use and for the use of its successors, assigns or other legal representatives, together with all of


the income, royalties, damages and payments now or hereafter due or payable with respect thereto, and all claims for damages by reason of past, present and future infringement of the rights assigned under this ASSIGNMENT with the right to sue for and collect the same for its own use and benefit, and for the use and benefit of its successors, assigns and other legal representatives, as fully and entirely as the same would have been held and enjoyed by ASSIGNOR if this transfer to ASSIGNEE had not been made;

ASSIGNOR covenants that it will, when requested, execute deliver and acknowledge all such further instruments of conveyance and do and perform all such other acts and things as ASSIGNEE may reasonably require to more effectively accomplish the assignment, transfer and recordation thereof of the PATENT APPLICATIONS and other applications claiming priority/benefit on the PATENT APPLICATIONS;
