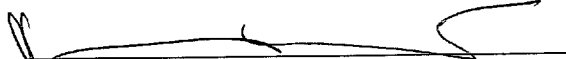
PATENT ASSIGNMENT

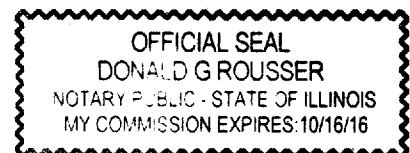

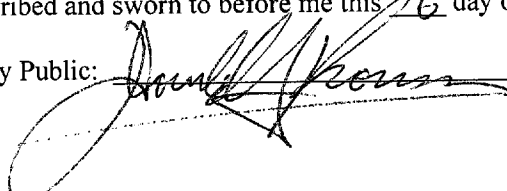
