granted for the Inventions in any foreign country; any and all refilings, extensions, renewals, reissues, divisions, continuations and continuations-in-part of any applications or Letters Patent referred to above; and the right to apply for or continue prosecution for any of the foregoing as well as to revive prosecution for any abandoned rights to any of the foregoing.

Kansas Aimers does hereby assign to Missouri Aimers the entire right, title and interest of Kansas Aimers in any Trademarks used by Kansas Aimers, together with the goodwill of the business symbolized by the marks and including all common law rights.

Kansas Aimers does hereby assign to Missouri Aimers the entire right, title and interest in the copyrights of any work product created by employees, officers, and directors of Kansas Aimers within the scope of their employment by Kansas Aimers.

Kansas Aimers does hereby assign to Missouri Aimers the entire right, title and interest in any trade secrets of Kansas Aimers.

The rights assigned herein include all claims for damages by reason of past infringements or violations of the rights assigned herein along with the right to sue and collect for such past infringements and violations.




to Missouri Aimers all Letters Patent or similar legal protection for the Inventions.

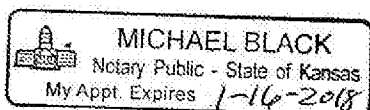



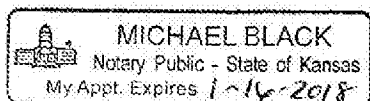
