THIS IS THE LAST WILL AND TESTAMENT of me NORTON BEDE WHITEFORD of
40 Moonbi Lookout Road MOONBI in the State of New South Wales.

- 1 I REVOKE all former Wills and testamentary dispositions made by me AND
DECLARE this to be my last Will and Testament.
- 2 PROVIDED my wife JENNIFER LEE LAURIE WHITEFORD survives me by a
period of thirty (30) days from the date of my death then I APPOINT her executrix of
this my Will AND I GIVE the whole of my estate of whatsoever kind and wheresoever
situate to my wife for her own use and benefit absolutely.
- 3 SHOULD my wife JENNIFER LEE LAURIE WHITEFORD not survive me by a
period of thirty (30) days from the date of my death THEN I APPOINT MATT
JOHNSON PAGE executor and trustee (hereinafter called "my Trustee") of this my Will
AND I GIVE the whole of my estate of whatsoever kind and wheresoever situate to my
Trustee UPON THE FOLLOWING TRUSTS:-

- 3.1 To pay all my just debts funeral and testamentary expenses and all duties payable
by reason or in consequence of my death;
- 3.2 To divide the residue between such of my son CRAIG BEDE WHITEFORD
and Stepson MATT JOHNSON PAGE as shall be living at the time of my death
and have attained or shall attain the age of twenty-one (21) years and if more than
one as tenants in common in equal shares HOWEVER should any of my children
predecease me leaving a child or children living at the time of my death who has
then attained or shall attain the age of twenty-one (21) years then such child shall
take by substitution and if more than one as tenants in common in equal shares
any benefit under this my Will which such child of mine so predeceasing me
would have taken had he survived me.

I direct that my Trustee shall have the following powers:

- 1 To invest trust funds in any form of investment, and at any time vary any
investment, as set out in section 14 of the *Trustee Act 1925*. The term
"investment" is expanded to include, in addition to its meaning at common law,
any property or interest in property held by my Trustee, whether or not it is held
with the expectation of profit or income and notwithstanding that it may be
speculative, hazardous or wasting.
- 2 To:
 - dispose of, whether by sale, exchange, partition, lease or otherwise;
 - call in and convert to money;



- transfer;
- subdivide;
- develop;
- manage; and
- generally deal with,

all real and personal property, as well as rights and options in relation to real and personal property, in all ways as if my Trustee were the absolute owner of it.

OR

.3 To postpone any of the transactions contemplated by this clause for so long as my Trustee thinks fit and to manage that part of my estate in the meantime, without being liable for any loss, including liability for taxation on capital gain.

.4 All powers as if my estate were held by my Trustee on trust for sale.

.5 To distribute all or part of my estate *in specie*.

.6 To pay all or part of any income or capital to which any beneficiary is entitled to that beneficiary for:

- maintenance;
- education; or
- otherwise for general benefit.

My Trustee may make any payments to a parent, guardian or other person responsible for the beneficiary's care, whose receipt shall be a good discharge. My Trustee shall not be responsible for the application of any payments made under this sub-clause.



.7 To determine whether receipts or outgoings are capital, income or a mixture of both. A determination will bind the beneficiaries.

.8 To stream income depending upon the different characteristics it may have and to deal separately with the streams. Without limitation, my Trustee may distribute one stream wholly to one or more beneficiaries to the exclusion of others, or accumulate income from a stream.


.9 Section 14C(1) of the *Trustee Act 1925*, which requires a trustee to have regard to various matters when exercising a power of investment, does not apply to my Trustee.

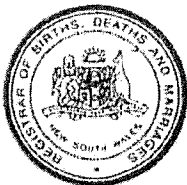
