The General Meeting, ruling under the quorum and majority conditions required for Ordinary General Meetings, having considered the report of the Board of Directors, ratifies the decision of the Board of Directors dated 5 February, 2014, in accordance with Article L. 225-36 of the French Commercial Code, to transfer the registered office of the company, with effect from May 19, 2014, from 3, avenue Octave Gréard 75007 Paris to 148/152 route de la Reine, 92100 Boulogne-Billancourt and to amend Article 4 of the articles of association accordingly, which now reads as follows:

"Article 4 - Registered office

The registered office is at 148/152 route de la Reine, 92100 Boulogne-Billancourt."

This resolution, after being put to a vote, was adopted with 1,344,179,171 votes in favor, 9,644,796 votes against, and 1,566,185 abstentions.
