AND, for the same consideration, **Assignor** agrees to communicate to the said **GRAPHIC PACKAGING INTERNATIONAL, LLC**, its successors, legal representatives and assigns, any facts known to **Assignor** respecting said invention, sign all lawful papers, execute all provisional, non-provisional, divisional, continuation, continuation-in-part, reissue and other applications, make all assignments and rightful oaths, and generally do everything possible to aid **GRAPHIC PACKAGING INTERNATIONAL, LLC**, its successors, assigns, and nominees, to obtain and enforce proper protection for all said inventions and improvements in all countries throughout the world.
