ASSIGNMENT

We, Frieder Loesel, residing at Bassemannstr. 38, 68165 Mannheim, Germany; and Gwillem Mosedale, residing at Skabiosenplatz 16, 80995 Muenchen, Germany, have invented a method and apparatus entitled POSTERIOR CAPSULOTOMY USING LASER TECHNIQUES, hereinafter called the "invention."


Cooperation to the best of our ability in the execution of all lawful documents, the production of evidence, nullification, reissue, extension, or infringement proceedings involving said invention.
