This PATENT ASSIGNMENT ("*Assignment*") is entered into as of February 6, 2012 (the "*Effective Date*"), by **Kollmorgen Corporation**, a New York corporation ("*Assignor*") in favor of **L-3 Communications Corporation**, a Delaware corporation ("*Assignee*").

Assignor hereby sells, assigns, transfers, conveys and delivers to Assignee all of Assignor's right, title and interest in and to the Patents, including, without limitation, all letters patent, applications for letters patent, divisions, continuations, continuations-in-part, provisionals, renewals, reissues, reexaminations, and any extensions thereof, now or hereafter arising, including any and all rights to sue at law or in equity for any infringement, impairment or other unauthorized use or conduct relating to the Patents occurring prior to the Effective Date, including the right to receive all proceeds and damages therefrom.
2. Assignor hereby requests the Commissioner of Patents and Trademarks in the United States Patent and Trademark Office, and the corresponding entities or agencies in any applicable foreign countries or multinational authorities, to record Assignee as the assignee and owner of the Patents and to deliver to Assignee, and to Assignee's attorneys, agents, successors or assigns, all official documents and communications as may be warranted by this Assignment.
3. Assignee, its successors and assigns, shall hold the rights to the Patents for and during the existence of such Patents, and all renewals thereof, as fully and as entirely as the same would have been held and enjoyed by Assignor had this Assignment not been made.
4. This Assignment is effective as of the Effective Date. Assignor shall, without further consideration, comply with a reasonable request by Assignee, at Assignee's expense, to execute promptly any additional documents provided by Assignee and to take promptly any further action necessary to protect, secure and vest good, marketable title to the Patents in Assignee.


