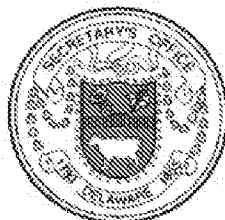

"FIRST. The name of the corporation is LiquidPower Specialty Products Inc."


