RELEASE PATENT SECURITY INTEREST

THIS RELEASE OF PATENT SECURITY INTEREST (this "Release") is made as of May 4, 2018 ("Effective Date") by ANTARES CAPITAL LP, as Administrative Agent (the "Administrative Agent"), in favor of INTERSECTION DESIGN AND TECHNOLOGY, INC. (f/k/a CONTROL GROUP, INC.), a Delaware corporation (the "Grantor"). All terms not herein defined, have the meanings set forth in the Security Agreement or Patent Security Agreement referenced below.

WHEREAS, Grantor and the Administrative Agent are parties to that certain Guaranty and Security Agreement dated as of September 15, 2015 (as may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") executed in order to secure the prompt and complete payment, observance and performance of all of the Obligations in accordance with the terms and conditions of the various loan documents;

WHEREAS, pursuant to the Security Agreement, the Grantor was required to execute and deliver a Patent Security Agreement dated as of September 15, 2015 (the "Patent Security Agreement") to the Administrative Agent for purposes of filing with the United States Patent and Trademark Office ("USPTO");

WHEREAS, pursuant to the Security Agreement and Patent Security Agreement, the Grantor granted to the Administrative Agent on behalf of the Lenders, among other Collateral as set forth therein, a continuing security interest in all of the Grantor's right, title and interest, in, to and under the United States patents registrations and applications listed on the attached Schedule A (the "Patents");

WHEREAS, the Patent Security Agreement was recorded in the USPTO on September 15, 2015 at Reel/Frame 036571/0773; and

WHEREAS, the Administrative Agent wishes to release its security interest in the Patents.


