AND ARGUELLO DOES HEREBY authorize and request the Director of the U.S. Patent and Trademark Office to issue the said Letters Patent, when granted, to said LLC, its successors and assigns, as assignee of the entire right, title, and interest in and to said improvements and INTELLECTUAL PROPERTY, for the sole use and behoof of said LLC, and for its successors and assigns to the full ends of the terms for which Letters Patent may be granted.

AND ARGUELLO further grants to LLC, its successor and assigns, the right to claim for any application for patent for said improvements the full benefit of any international agreement between the United States and any foreign country or countries.

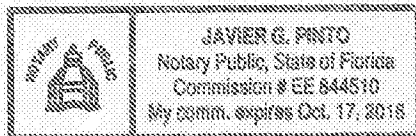


