

### RELEASE OF SECURITY INTEREST IN PATENTS

This RELEASE OF SECURITY INTEREST IN PATENTS (this "Release"), dated as of April 6, 2018, (the "Effective Date"), is made by PNC Bank, National Association, in its capacity as collateral agent (the "Agent"), in favor of the grantor parties identified on Annex A hereto (the "Grantors").

WHEREAS, the Grantors executed and delivered for recordal with the United States Patent and Trademark Office the intellectual property security agreements listed on Annex B hereto (together, the "Patent Security Agreements"), pursuant to which such Grantors granted to the Agent a security interest in all of such Grantors' right, title and interest in and to the United States Patent registrations and applications set forth in Schedule 1 hereto (collectively, the "Collateral");

WHEREAS, the Patent Security Agreements were recorded with the United States Patent and Trademark Office at the Reel and Frame numbers listed on Annex B hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

- 1. <u>Defined Terms</u>. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Patent Security Agreements.
- 2. <u>Release</u>.
