
2. Said Assignor hereby warrants and represents that, at the time of execution and delivery of these presents, said Assignor was the lawful owners of the entire right, title, and interest in and to said inventions and said applications for Letters Patent, and that the same had not entered into any assignment, contract, or understanding in conflict herewith.

3. Said Assignor hereby covenants and agrees to assist and cooperate with said Assignee, whereby said Assignee may enjoy to the fullest extent said right, title, and interest herein conveyed, provided, however, that the entire expense with respect to time, efforts, as well as any out-of-pocket expenses that are approved by the Assignee and that may be incurred by said Assignor in lending such assistance and cooperation be paid by Assignee should the Assignor no longer be in the employ of the Assignee. Such compensation shall be provided at a mutually agreeable rate to be determined. Such cooperation shall include: (a) prompt execution of all papers (prepared at the expense of Assignee) that are deemed necessary or desirable by Assignee to perfect said right, title, and interest herein conveyed, (b) prompt execution of all petitions, oaths, specifications, declarations, and other papers (prepared at the expense of Assignee) that are deemed necessary or desirable by Assignee for filing or prosecuting in the United States or any foreign country said applications, any applications which are a division, continuation, or continuation-in-part of said applications, any reissue application for any Letters Patent granted on said applications, or for any contested proceeding before the Patent Trial and Appeal Board involving said applications or Letters Patent granted thereon; and (c) prompt assistance and cooperation in the prosecution of all legal proceedings involving said inventions, said applications, or Letters Patent granted thereon, including but not limited to oppositions, cancellation proceedings, priority contests, public use proceedings, re-examinations, covered business method proceedings, inter partes review proceedings, and court actions.

4. The terms, covenants and conditions of this Assignment shall inure to the benefit of said Assignee, its successors, assigns, and/or other legal representatives, and shall be binding upon said Assignor, his heirs, legal representatives, and assigns.

5. Said Assignor hereby requests the Commissioner of Patents and Trademarks to issue said Letters Patent of the United States to said Assignee as the Assignee of said inventions.
