ASSIGNMENT

This Assignment is effective as of the date of signing by the last of the Parties to sign below and is by and between Felicia Gray of Goldendale, WA (hereinafter Gray), Garry Beaudette of Wenatchee, WA (hereinafter Beaudette) and Keyes Packaging Group, Inc. of Wenatchee, WA, (hereinafter Keyes). Collectively Gray, Beaudette and Keyes are referred to as the Parties.

The Parties agree as follows:

1. Beaudette and Gray are the co-inventors of a design for a Paint Palette. For purposes of identification only, upper and lower perspective views of one embodiment of the Paint Palette is found in Exhibit A to this Assignment, which is incorporated by reference herein. The term Paint Pallet includes the design of Exhibit A set forth below together with any modifications to the Exhibit A design.

2. Beaudette performed his work on the Paint Palette as an employee of Keyes.

3. Gray and Beaudette intend to file a US Design Patent Application on the Paint Palette. Such Design Patent Application is identified as follows (the Filing Date and Serial Number to be filled in following filing of the US Patent Application):

COMPRESSED PULP PAINT PALETTE; filed May 18, 2018, assigned
Application Serial No. 29/648,263.

4. Keyes and Beaudette desire to assign all of their rights in the Paint Palette to Gray.

5. Gray promises to pay Beaudette fifty dollars (\$50.00 US) as full consideration for his Assignment. The consideration for Keyes is an Exclusive Supplier Agreement dated April 16, 2018 between Gray and Keyes. This assignment shall remain in effect in the absence of any termination of the Exclusive Supplier Agreement by Supplier for the reasons set forth in paragraph 7.(a) of the Exclusive Supplier Agreement.

6. For good and valuable consideration, Beaudette, and Keyes to the extent Keyes has any rights therein, hereby sell, assign and transfer to Gray, the full and exclusive right, title and interest in and to the Paint Pallet, to all patent applications filed for the Paint Palette, including the above identified US Patent Application, and all patent rights pertaining to the Paint Palette throughout the world, including foreign priority rights; said inventions, applications and letters patent of the United States or any foreign country, and all divisions, continuations, reissues and extensions thereof, to be held and enjoyed by Gray, for her own use and benefit, and for her successors and assigns to the full end of the term for which letters patent may be granted by the United States or any foreign country, as fully and entirely as the same would have been held by Beaudette and Keyes had this assignment and sale not been made. Beaudette and Keyes covenant that they have the full right to enter into this Assignment and that they have not granted any rights in the Paint Palette to any other party and are under no obligation to do so. Keyes and Beaudette covenant to communicate to Gray, or her successors and assigns, any facts known to them respecting said invention, and sign to all lawful papers including declarations, required in connection with any patent filings.

7. The Parties hereby grant the law firm of Klarquist Sparkman, LLP, the attorneys for Gray, the power to insert on this Assignment the serial number and filing date of the application referred to in the first paragraph of this Assignment after they are known. This Assignment may be executed in counterparts, with each counterpart having the effect as an original document. Gray intends to record this Assignment with governmental authorities.

8. Gray hereby accepts the rights transferred by this Assignment.


