RELEASE OF PATENT SECURITY AGREEMENT

THIS RELEASE OF PATENT SECURITY AGREEMENT (this "Release"), dated as of May 29, 2018, is made by **KeyBank National Association**, a National Banking Association, ("Secured Party"), and is as follows:

WHEREAS, Astute, Inc., an Ohio corporation ("Debtor") and Secured Party are parties to that certain Grant of Security Interest – Patents, dated as of May 22, 2014 (the "Agreement"), which was recorded with The United States Patent and Trademark Office on May 29, 2014 in its records at Reel 033032, Frame 0001; capitalized terms used but not defined herein will have the meaning given to them in the Agreement;

NOW, THEREFORE, intending to be legally bound hereby and in connection with the Agreement, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby (i) fully and finally releases, discharges, and terminates its security interest and other rights in, to and under the Patents and any and all other rights it may have under the Agreement with respect to the Patents, without any recourse, representation or warranty, (ii) terminates the Agreement, and (iii) re-assigns to the Debtor any right, title or interest the Secured Party may have in, to or under the Patents and hereby authorizes the Debtor or the Debtor's authorized representative or designee to record this Release along with other necessary documentation with the United States Patent and Trademark Office or any other governmental office to evidence the release granted herein. Secured Party will execute such further documents as deemed reasonably necessary by Debtor to confirm and effect this Release.
